Printing specifications

The print-ready ad can be sent as a PDF, EPS, TIF, JPG and must correspond to the size of the booked ad. Fonts and images must be embedded in EPS data, TIF and JPG should also have a resolution of 300 dpi. The color space is exclusively CMYK, no special colors are possible. No data in the form of Word and Powerpoint files, web resolution, RGB. If an ad has to be created by XTRA! using text, images, graphics, logos, this will be invoiced. The resolution of all submitted documents in a quality of at least 300 dpi must be taken into account here. These documents must be submitted no later than seven days before the editorial deadline.

Transmission of print data

The print-ready advertisement reaches XTRA! by email (office@xtra-news.at) or via a download option notified to us – the documents must be submitted in good time before the editorial deadline. Advertisements that arrive late must be announced and confirmed in advance by telephone, otherwise the advertisement cannot be included in the booked edition.

Advertising order

The advertising order is binding and will be confirmed in writing regarding size, price, frequency and placement. Discounts, rebates and agency discounts will only be granted following prior consultation and written agreement. If a second reminder is unsuccessful, the promised discounts will expire and the list price will become due.

Placement of the advertisement | Placement guarantee

The advertisements will be placed in the best possible way, unless there is a preference for a particular placement. The deciding factor is the space available and in particular the layout of the magazine, so that no specific page can be guaranteed for the advertisement. If there is a preference for a placement when booking (right page, specific page, etc.), a surcharge of 20% will be charged on top of the respective advertisement costs (placement guarantee).
